**Zimmer Biomet provides grants for fellowship programs in the following orthopaedic areas:**

2. Joint Arthroplasty Extremities (incl. Shoulder, Elbow, Hand & Wrist, Foot & Ankle)
3. Sports Medicine
4. Degenerative and Deforming Conditions of the Spine

To be eligible for grant consideration, a fellowship program must be accredited by the Australian Orthopaedic Association (AOA) or the New Zealand Orthopaedic Association (NZOA).

All applications will be reviewed by the relevant regional Zimmer Biomet Grants Review Committee (GRC) and the following criteria will be taken into consideration when determining the success or otherwise of an application:

- Supervisors – level of clinical, research and teaching experience and expertise
- Fellowship curriculum – well defined goals and objectives
- Teaching institution – quality of facility and its research capabilities, other expertise
- Fellowship history
- Research topic

- Letter of request (incl.):
  - length of fellowship (start and finish date);
  - level of funding support requested and how funds will be distributed;
  - program supervisor/s name/s and position/s;
  - overview of the fellowship program including its history and objectives
- AOA and/or NZOA accreditation certificate
- CVs of lead supervisors
- Detailed position description for the fellowship program
- List of directors and executive officers of the requesting party
- Grant usage report (if previous recipient)
- AOA fellow/s and supervisor/s reports (if previous recipient)

For fellowships starting the first half of 2018:

- August, 2018                      Applications close
- October/November, 2018      Announcements made

For fellowships starting the second half of 2018:

- March, 2019                        Applications close
- May/June, 2019                    Announcements made
